### **OBJECTIVE**

To raise awareness and empower water managers on the issue of gender inequality and the importance of articulating the themes "gender" and "water" for the effectiveness of water management. To present tools for gender incorporation in Integrated Resources Management. To get to know good practices in Brazil and in the world.

## **LANGUAGES**

The course will be taught in Portuguese with simultaneous translation into Spanish and English.

## **TARGET AUDIENCE:**

The course is aimed at technicians and professionals of water and environmental management organizations in Brazil, Latin American countries, the Caribbean and other Portuguese-speaking countries responsible for the implementation of water resources public policies and management tools.











## **METHODOLOGY**

The course has 32 class/hours schedule to be carried out on-line and face-to-face. The course consists of three modules: conceptual framework, interface between gender and water and incorporating gender into practice. Its methodology will include the adoption of a critical stance, valuing the relationship between theory and practice and the interdisciplinarity of the actions involved in the teaching-learning process. For this purpose, the following working methodology will be used: online lessons, reading of assigned literature and exercises to verify the reading and learning. Complementary materials will also be indicated to provide students with tools that have a logical connection to the materials made available in different languages (texts, videos, animations, etc.). The lessons will cover theoretical issues and case studies on water management, according to the following schedule:

### **APPLICATIONS AND LOGISTIC ASPECTS:**

- the applications must be submitted from August 28<sup>th</sup> to September 22<sup>nd</sup> of 2019 through the form available at ANA's Capacity Building website (<a href="http://capacitacao.ana.gov.br/">http://capacitacao.ana.gov.br/</a>)
- **criteria for the selection of participants**: the main criteria used for selection is that the candidates should be employees whose working duties are directly related to the course's theme, namely in the implementation of public water resources policies and management instruments. In order to be qualified to participate in the course, applicants should preferably:
  - a) Be linked to water management organizations, in the national, state or municipal sphere;
  - b) Be a water resources manager and/local technician responsible for themes related to the object of the course;
  - c) Have over three (3) years of experience in the related area;
- Participation costs for the selected applicants will be covered by the organizing institutions, **including**:
  - ✓ Costs related to the course;
  - ✓ Transportation from the Brasília airport to the hotel (hotel to be defined), and vice versa, for foreign participants;
  - ✓ Hotel fees (exclusively for foreign applicants from Latin American, Caribbean and Portuguese-speaking countries);
  - ✓ Meals, namely:
    - Breakfast at the hotel (exclusively for foreign applicants from Latin American, Caribbean and Portuguese-speaking countries);
    - Lunch at the course site;
    - Dinner at the hotel (including on November 11<sup>th</sup> of 2019, exclusively for foreign applicants from Latin American, Caribbean and Portuguese-speaking countries)
